INSTRUCTIONS

- 1. A shareholder desiring to exercise vote may complete this Postal Ballot Form in original and send it to the Scrutinizer in the attached pre-addressed envelope on which postage will be paid by the company. However, envelopes containing Postal Ballot Forms, if sent by courier or registered post, at the expense of the shareholder, will also be accepted.
- 2. This form should be completed and signed by the shareholder. In case of joint holding, this form should be completed and signed (as per the specimen signature registered with the Company) by the first named shareholder and in his absence, by the next named shareholder.
- 3. Unsigned Postal Ballot Forms will be rejected.
- 4. Duly completed Postal Ballot Form should reach the Scrutinizer not later than 5.00 PM IST on May 22, 2018. All Postal Ballot Forms received after this date will be strictly treated as if reply from such shareholder has not been received.
- 5. In case of shares held by companies, trusts, societies etc, duly completed Postal Ballot Form should be accompanied by a certified true copy of Board Resolution/Authority.
- 6. Voting rights have been reckoned on the paid up value of the shares registered in the name of the shareholders as on April 6, 2018.
